

# SID and SGX Group Commemorate 25 Years of Championing Good Governance

**Singapore, 28 July 2023** - To celebrate its 25th anniversary, the Singapore Institute of Directors (SID) launched an accreditation framework for board directors and an alliance of more than 100 organisations to champion governance for good.

The two initiatives were announced by Deputy Prime Minister and Minister for Finance Mr Lawrence Wong at an event which also commemorates a 25-year partnership between SID and Singapore Exchange (SGX Group) to promote corporate governance.

Held at SGX Centre, the commemorative event was streamed live on social media and attended in person by more than 160 apex-level representatives of organisations that include government bodies, trade associations, chambers, professional bodies, professional services firms and educational institutions.

"We are grateful to have DPM Wong mark this important milestone with us and for launching the two initiatives. Accreditation will uplift the directorship profession by promoting continuous improvement, competent leadership and stakeholder confidence; while the Alliance will harness the collective efforts across the directorship ecosystem to champion good governance," said Wong Su-Yen, Chair of the SID Governing Council.

"I would also like to thank the many Council members, SID staff, partners and SID members – both past and present – who have made invaluable contributions and laid the foundation for the next 25 years of SID."

# Setting Professional Standards and Communicating Director Competencies

From January 2024, eligible SID members will be invited to apply for accreditation. Successful candidates will be able to add to their credentials "Accredited Director" or "Senior Accredited Director" if they have more than five years of directorship experience.

Developed by SID with support from an Accreditation Committee comprised of SID members who are researchers, academics, experienced directors and corporate governance experts, the framework was endorsed by the SID Governing Council and reviewed and supported by representatives of third-party bodies including Singapore Exchange Regulation (SGX RegCo), ACRA and the Charities Unit.

The foundation of the accreditation framework is the SID Director Competency model, which articulates eight areas of competencies that directors need to exhibit in the boardroom. These are: (a) governance, (b) director duties and practice, (c) financial skillsets, (d) risk management, (e) strategy development, (f) digital skillsets, (g) human capital and (h) sustainability fundamentals.



"Designed to establish standards for director competencies, the accreditation framework provides directors with structured development pathways to acquire essential knowledge, skills and attributes, and enables directors to stay relevant over time through continuous professional development," said co-chairs of SID Accreditation Committee Philip Forrest, AM and Dr Fermin Diez. "It also enables directors to communicate their competencies to boards that are looking to appoint directors."

## More than 100 Organisations Assemble to Champion Good Governance

The SID Governance for Good Alliance brings together key stakeholders in the directorship and governance ecosystem who are committed to good governance and support SID's work.

The Alliance recognises stakeholders who have supported SID's work in the past, and who continue to amplify SID's efforts by collectively contributing time, talent, treasure, ties and testimonials. It is a signal that good governance requires an ecosystem-wide approach and a rally for others to join the cause.

The Alliance comprises more than 100 founding partners which are regulators, government agencies, professional services firms, professional bodies, trade associations and chambers, institutes of higher learning and other institutions in the directorship or governance space.

SGX Group, an organisation that has supported SID's work since its inception in 1998, is a Founding Partner of the Alliance.

"Singapore Exchange will continue the strong partnership with SID in years to come, with programmes and initiatives that are regularly refreshed and enhanced," said Loh Boon Chye, Chief Executive Officer, Singapore Exchange (SGX Group). "These efforts build upon our joint commitment towards high standards of corporate governance in Singapore for the benefit of our entire ecosystem."

## **About Singapore Institute of Directors**

Customised courses and closed-door board conversations also form part of our offerings.

SID connects and strengthens the ecosystem with initiatives such as mentoring and networking. ## ANNEX C

### **SID Accreditation Framework**

From January 2024, eligible SID members can choose to go through an accreditation process. Successful candidates will be able to add to their credentials "Accredited Director", or "Senior Accredited Director" if they have more than five years of directorship experience.

The SID's Director Accreditation framework establishes standards for director competencies in the following ways:

- To provide directors with structured development pathways to acquire essential knowledge, skills and attributes.
- · To enable directors to stay relevant over time through continuous professional development.
- To communicate director competencies to boards looking to appoint directors.

The foundation of the Accreditation framework is the SID Director Competency model, which reflects eight competencies that directors need to exhibit in the boardroom. These are:

- (a) Governance.
- (b) Director duties and practices.
- (c) Financial skillsets.
- (d) Risk management.
- (e) Strategy development.
- (f) Digital skillsets.
- (g) Human capital.
- (h) Sustainability fundamentals.

The framework is designed to support directors of all organisations, whether listed entities, statutory boards, private companies, family firms, high-growth ventures or nonprofit organisations.

A director might start by going through a series of core modules covering each of the eight competencies. The director could subsequently earn badges by taking up supplementary modules to gain knowledge and skills specific to board roles, functional expertise and organisation type.

For example, a director serving on nonprofit board might complement the core modules with badges in volunteer management or fundraising. Another director of a listed entity would need to acquire the badges that come with the completion of programmes mandated by Singapore Exchange Regulation for first-time directors.

The Accreditation framework also enables directors to chart their personal continuing education roadmap to ensure they stay current and relevant.

There are many paths to board directorship. This Accreditation framework is designed to enable leaders from diverse backgrounds to effectively serve as directors of the organisations they helm.

More details about the accreditation process will be shared in October 2023.



## ANNEX D

## **SID Governance for Good Alliance**
